TERMS & CONDITIONS of GOLF MEMBERSHIP

- 1. MEADOWBROOK GOLF CLUB** is owned and operated by a private company, Meadowbrook Golf Pty Ltd. All property, equipment, licenses, and staff are controlled by the company through its appointed Club General Manager. Meadowbrook Golf Club confers no rights or obligations with respect to its property, assets, liabilities or management on any person by acceptance of their application to membership.
- 2. THE FINANCIAL / MEMBERSHIP YEAR** for Meadowbrook Golf Club memberships is 12 months from the day the application form is accepted and the relevant annual fee has been paid. Renewals to subscriptions are effective immediately upon expiry of the applicable financial year. Memberships once paid are not refundable in any circumstances. The maximum term of membership is 12 months and no guarantee is made for continuance of membership for further periods.
- 3. MEMBERSHIP** packages have been formulated to provide a versatile range of benefits. All entitlements are conferred to the owner of the membership only and cannot be transferred, sold or gifted to any other person without exception. Members found to be in breach of this condition will be subject to immediate suspension of entitlements. All club competition prize points accrued on a member's card are redeemable ONLY for products sold within the clubhouse and pro-shop. Points are not valid to form payment for competition or membership fees, nor part thereof and cannot be converted to cash.
- 4. RULES OF PLAY: MEMBERS MUST** report to the Pro Shop 15 minutes prior to all play and produce their current membership card for registering of play and/or payment of appropriate fees. Failure to produce current membership card may result in the refusal of play. Failure to register at the Pro Shop prior to accessing the golf course may result in suspension of membership.
- 5. MEMBERSHIP BY LAWS** apply to all persons who have applied for and been accepted for membership of Meadowbrook Golf Club in whatever category. These rules shall form the basis of the member's relationship with Meadowbrook Golf Pty Ltd as proprietor of Meadowbrook Golf Club and with all other members.
- 6. MEADOWBROOK GOLF CLUB** may reject any application for membership, without assigning any reason.
- 7. MEADOWBROOK GOLF CLUB** may establish and adjust fee structures and make rules for management of its facilities. This includes, but is not limited to, from time to time adjustment of booking times, hours of operation and the closure of facilities for tournaments, weather conditions, maintenance or other reasons.
- 8. CART MEMBERSHIP** entitles the financial member use of a cart for **18 holes per day only** within their membership category playing time. **The entitlement extends to the financial member only.** In the event that there are 2 cart members or players paying for the hire of a cart in the same playing group, **the cart must be shared.** This will be managed by the pro shop staff. To help create a better playing surface on the golf course carts are not to be driven within 10 metres of any putting surface and, where possible, carts should remain on paths.
- 9. OBLIGATIONS OF MEMBERS:** Upon acceptance to membership, you will be issued with a membership card for the applicable period, which must be displayed at all times. Members are required to behave properly, i.e. not damage or deface MGC property, or put at risk, purposely injure or be abusive to other players persons while playing on the golf course or using its facilities.
- 10. MEADOW BROOK GOLF CLUB** may cancel the membership of any person or refuse permission for that person to use its facilities if that member breaches these rules, or is guilty of misconduct within the facility or elsewhere, which in the opinion of Meadowbrook Golf Club, is contrary to the best interest of other members or reflects badly upon Meadowbrook Golf Club. No refunds are payable for the termination of membership from any cause.
- 11. LIABILITY**
Members exercise their rights and come upon and use the facilities of Meadowbrook Golf Club at their own risk. Meadowbrook Golf Club will not be liable for damage to or loss of property of any member. Each member indemnifies and keeps indemnified Meadowbrook Golf Club and its staff against any loss or damage to any person or property howsoever arising and whether caused within the facility or otherwise. Notwithstanding the foregoing Meadowbrook Golf Club will refer a bona fide claim to its insurer in which case any applicable excess shall be payable by the member and not Meadowbrook Golf Club. This excess fee is withheld from any payment made.
- 12. AMENDMENT OF RULES**
These Terms & Conditions of Membership and Code of Conduct are designed to aid the efficient operation of the facilities of Meadowbrook Golf Club for the benefit of all. They may be changed by the management of the Golf Club at any time.
- 13. MEMBER'S DETAILS** (mobile, address or email) may be used for mailing purposes.
- 14. AFFILIATION FEES** of \$86 are payable to Golf Australia for the 2020 year for those members who wish to have an official handicap
